I am writing further to the Conditional Approval of the above establishment under Regulation (EC) No 853/2004¹ granted on 16 March 2020.

Following the on-site visit to the above establishment on 11 June 2020 and recommendation by Frances Moreno, Field Veterinary Leader, the Food Standards Agency (FSA) has granted this establishment **Full Approval** with effect from the date of this letter in accordance with article 148 of Regulation (EU) 2017/625², to operate as a **Cutting Plant, Minced Meat Establishment, Meat Preparations Establishment, Re-Wrapping Establishment and Cold Store.**

The full approval document is attached at **Annex A**. **Approval Number 1037** remains allocated to the establishment.

The approved establishment comprises all those buildings, rooms and areas within the boundary outlined in red on the plan attached to the original approval document. Any buildings or areas outside the area outlined in red must not be used for any activities connected with the proper running of the establishment.

Responsibility for complying with the Hygiene Regulations³ rests with **Parkers Food Service Ltd** as the food business operator. The FSA will undertake official controls to verify compliance with the Hygiene Regulations at this establishment.

In accordance with article 148 of Regulation (EU) 2017/625, the FSA will keep the approval of the establishment under review when carrying out official controls. The FSA has the right, in certain circumstances, to withdraw or suspend approval.

In accordance with the Official Feed and Food Controls (England) Regulations 2009, any person who is aggrieved by a decision taken by the FSA in respect of an establishment subject to approval may appeal to a Magistrates' Court. The time limit for lodging an appeal is one month from the date on which notice of the decision is served on the person wanting to appeal against this notification.

The FSA must be informed of any significant change to food business operations, such as additional activities, changes to the approved curtilage, change of FBO, the closure of an establishment or surrender of approval. This is to ensure the FSA always has up-to-date information on establishments in compliance with Article 6(2) of Regulation (EC) No 852/2004. **Not complying with this requirement is an offence under the Food Safety and Hygiene (England) Regulations 2013.**
